Application Procedure Safety Precautions

- 1. Flush all equipment with Equipment Cleaner before use.
- 2. Stir base using an explosion-proof power mixer to disperse pigments.
- 3. Add XL-10B Activator to XL-10A base. Mix thoroughly until uniformly blended to a workable consistency.
- 4. Do not mix more material than can be used within the expected pot life. Pot life is the time after mixing that a 5-gallon unit is sprayable. A mixture may appear fluid beyond this time, but spraying and film build characteristics may be impaired.
- 5. For optimum application, material should be from 50 to 90° F (10 to 32 °C). Above 122° F (50°C), sagging may occur.
- 6. Apply a wet coat in even, parallel passes with 50 percent overlap to avoid holidays, bare areas and pinholes. If required, cross spray at right angles.
- 7. Ventilate confined areas with clean air between coats and while curing the final coat. Prevent moisture condensation on the surface between coats.
- 8. Repair damaged areas by brush or spray.
- 9. Clean equipment immediately after use. May use thinner, or Consult Mirage Products, LLC.

- 1. LIMITED WARRANTY COVERAGE—FINISH ONLY. Subject to the terms, conditions, and limitations described below, Mirage Products, LLC ("Mirage Products") warrants that the finish of Xylexin® ("Xylexin"), as applied by Mirage Products or its trained and authorized installers, to stone, ceramic, porcelain tiles, concrete, or other substrates authorized in writing by Mirage Products ("Substrates"), for a period of ten (10) years from the date of application of the product (the "Warranty Period"), will be free from defects in manufacture or application and will not itself: peel, crack, fade, stain, or chip (collectively, "Damage"). In the event such Damage occurs during the Warranty Period, Mirage Products, as its sole liability and in lieu of any direct, indirect or consequential damages will, during the first year, pay for reasonable fees for replacing materials in an amount equal to the purchase price of the product, with such reimbursement decreasing by 10.0% per year during each of the following 9 years. Mirage Products makes no warranty of any kind with respect to any cracking, chipping or failure of Substrates on which Xylexin is applied.
- CONDITIONS OF WARRANTY. This warranty is subject to the following terms and conditions:
 - This warranty applies only to the original purchaser of Xylexin and all transferees prior to and including the owner of the structure on which such Xylexin is installed at the time of installation.
 - b. This warranty applies only to Xylexin installed in the United States, its trust territories, or Canada.
 - Xylexin must be installed according to the printed installation instructions supplied by the manufacturer of Xylexin, and according to all building codes adopted by federal, state or local governments or government agencies. Xylexin must be installed by a trained Xylexin installer authorized by Mirage Products. Failure to apply Xylexin according to the manufacturer's published instructions voids the warranty. Xylexin must be used for its intended purpose, as published by Mirage Products, on a Substrate.
 - d. Any unauthorized dilution, mixture or other adulteration of Xylexin voids this warranty.
 - To make a claim under this warranty, the claimant must, within thirty (30) days after discovery of any claimed Damage covered by this warranty, and before attempting any repair, provide written notice of the Damage to Mirage Products at the address shown below. This notice must include the following information:
 - i. Claimant's name, mailing address and daytime and evening telephone numbers where claimant may be reached concerning the claim;
 - ii. Proof that claimant is a person covered by this warranty;
 - iii. A copy of the warranty on which the claim is based;
 - iv. The address of the structure on which Xylexin is installed;
 v. The date on which Xylexin was purchased;

 - The date on which the installation of Xylexin occurred;
 - vii. A written description of the claim, including the Damage of the Xylexin finish that the claim asserts has occurred, the date on which the Damage occurred, the location and details of the Damage and such other information as is necessary for Mirage Products to investigate the claim; and
 - viii. A photograph of the Damage reported in the claim.

- f. The failure to notify Mirage Products of the claim within the thirty (30) day period or the failure to provide all of the required information concerning the claim shall bar the claimant from recovery under this warranty.
- g. The claimant must allow Mirage Products or its agent thirty (30) days after Mirage Products receives the written notice of claim required above, to examine, photograph and take samples of Xylexin that the claimant claims is Damaged.
- h. ANY REPAIR OF XYLEXIN UNDERTAKEN WITHOUT PRIOR WRITTEN AUTHORIZATION FROM MIRAGE PRODUCTS WILL VOID THIS WARRANTY.
- 3. EXCLUSIONS. This warranty does not cover Damage resulting from, or in any way attributable to:
 - Damage to Xylexin that occurs in connection with its transit, delivery, loading or unloading, or storage prior to installation;
 - b. The improper application of Xylexin;
 - c. Application of Xylexin by an installer not trained or authorized by Mirage Products;
 - d. Abuse, including the use of cleaning chemicals not approved by Mirage Products;
 - e. Misuse;
 - f. Re-use:
 - g. Repair or alteration not authorized by Mirage Products;
 - h. Settlement or structural movement and/or movement of Substrates to which Xylexin is attached;

 - m. Cracks, chips or other defects in the Substrate itself (instead of the Xylexin finish);
 - n. Environmental pollution; and
 - o. Any cause other than those resulting from defects or errors in the manufacture or application of the Xylexin finish.
